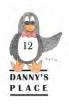

Danny's Place Youth Services

Future Plan

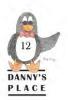
Since March 2006, Danny's Place Youth Center has been supported and managed by Danny's Place Youth Services (DPYS), a privately funded non-profit organization managed by a Board of Directors. Since its inception, the mission of DPYS was to provide a physical drop-in space and to run programs for youth that supported health and wellness through fun activities and entertainment. The Youth Center has proven to be a haven of social and emotional support for our community's youth at a critical stage in their development. In addition, DPYS awards three annual scholarships, and has provided financial grants to groups offering programs and activities in relevant areas.

Due to physical changes on the Acton school campus, the Youth Center can no longer be housed in the Administration building, and will close on April 25, 2014.

The general mission, management, and funding of Danny's Place will not change. However, the new physical space and programming will be fundamentally different:

- Danny's Place will reopen in the Fall of 2014 at 537 Massachusetts Ave in Acton
- The facility will be a gathering space with an office for the adult Executive Director, and will be open on a
 part-time basis for club meetings, small activity groups, and meetings with the Executive Director
- DPYS will support three types of programs through the facility, adult leadership, and funding:
 - 1. Youth led initiatives and activities based on the interests of individuals, with a variety of programs such as theater or civic
 - 2. Youth development programs offered by the 4-H Club, such as stress management or environment
 - Community-run programs such as Skid School, self-defense clinic, or community-based entertainment programs
- The guiding themes for all supported programs will be those expressed in the Life Skills Model used by 4-H
- The adult Executive Director will help youth define and implement initiatives and activities, oversee 4-H
 club meetings, evaluate and fund community-run programs, and participate in the scholarship award
 process

Superintendent Search Update and Community Forums

Interviews for the Superintendent search have begun, and will continue through this week. Once we have identified a slate of candidates to advance to the School Committee, each finalist will be invited to visit for a day, and participate in a series of meetings and forums with members of the community. We appreciate that this is a busy time of year for everyone and appreciate your involvement. Please be sure your calendar is marked for the School Committee meeting on **Saturday**, **January 25**th (9 a.m. in the **Junior High Library**) when the School Committee will hold their public interviews of the finalists.

Because of the short turnaround that we expect between the naming of the finalists and when the visits will take place, I would like to publicize the schedule of dates and times reserved for these finalist visits. We have *tentatively* scheduled 4 days, though we may or may not need all of them. Once finalists have been selected and announced, we will publicize which candidate is scheduled for each day.

On each day, the finalist will visit some schools, meet with Principals and members of the Superintendent's leadership team, and then participate in open forums with school staff, and Acton and Boxborough community members. Participants will be asked to complete a simple feedback form that will be shared with members of the School Committee. Below is the schedule for the open forums:

SECTION II: Goals and Visions

The responses for each item are Strongly Agree, Agree, Somewhat Agree, Somewhat Disagree, Disagree, and Strongly Disagree. We constructed a 6-point likert scale using these responses, then will calculate the mean response for each item and will list in table format as illustrated below.

I consider standardized test scores to be very important for measuring the academic success of the students and of the school's efforts to educate students.

The junior high and high school should do its best to increase its offering of accelerated and advanced courses for student swho are able to succeed in those course (i.e. gifted and talented programs)

SECTION III:Educational Values and Interests

Because of the way this scale was constructed, interpretation is tricky. For the purposes of this report, we will focus on the categories of "Of greatest importance", "Important", and "Educationally harmful". We will report percentages terms of those respondents identifying either "Of greatest importance" or "Important", as well as percentages of those responding "Educationally harmful".

Running for Office in Boxborough

Boxborough 2014 Town Election Calendar

Date of Election: Monday, May 19, 2014

Qualifications: Any registered voter residing in Boxborough may run for office.

Nomination Papers: Nomination Papers for town office are available from the Town Clerk starting January 13, 2014. Candidates must appear in person to take out papers or else provide a written request specifically stating the office he/she is interested in running for. Candidates must collect a minimum of 25 signatures of voters registered in Boxborough to get on the ballot.

Nomination Paper Filing Deadline: The deadline for submitting completed nomination papers to the Town Clerk's office for certification is Monday, March 24, 2014, at 5pm.

Campaign Finance Reporting: Candidates and their committees, if any, are required by state law to file periodic campaign finance reports with the town clerk. These reports must be filed whether or not any money has been raised or expended during the reporting period. The clerk will provide you with the forms and the schedule for filing.

PROCEDURES FOR RUNNING FOR LOCAL OFFICE

Qualifications

Any registered voter residing in the town of Acton may run for local office.

Nomination Papers

Nomination papers are available now through February 7, 2014 at the Town Clerk's Office at the Acton Town Hall (978-929-6620). The Clerk's office asks that a candidate submit, in writing, a request for nomination papers. The papers will be prepared by the Town Clerk. Candidates for office must gather the signatures of 50 registered Acton voters. Signatures must be legible and should not differ substantially from the way the names appear on the voting list.

No voter may sign more petitions for an office than there are vacancies. The Town Clerk will disqualify the signatures that exceed this limit.

The deadline for submitting completed nomination papers to the Board of Registrars at the Town Clerk's Office in Town Hall is February 11, 2014. It is suggested that each candidate collect more than the required signatures in the event of disqualification of any signature by the Board of Registrars. The deadline for withdrawing nomination papers is February 27, 2014.

Campaign Finance Reporting

Candidates and their committees, if any, are required by state law to file periodic campaign finance reports with the Town Clerk. These reports must be filed whether or not money has been raised or expended during the reporting period and whether or not the candidate is elected. Report forms may be obtained at the office of the Town Clerk and reports are due by the close of business according to a specific schedule.

This examination, consisting of questions from all areas of high school mathematics - Arithmetic, Number Theory, Algebra, Geometry, Trigonometry, Analytic Geometry, Probability, and Logic, is co-sponsored annually by the Massachusetts Association of Mathematics Leagues and the Actuaries Club of Boston.

Senior Nihal Gowravaram led Acton-Boxborough as the top school scorer, as well as the top scorer in Massachusetts. Also, placing in the top 100 statewide were Joshua Xiong. Niket Gowravaram, Akshay Karthik, Steven Jin, and Andrew Li. These six students will be invited to take the second level contest examination on March 4, 2014.

Ajay Saini and Richard Ding were named as semi-finalists by placing in the top 10% statewide.

The results of this examination are used to identify students with exceptionally strong mathematical ability, as well as to stimulate student interest in mathematics.

The finalists will receive awards from the Massachusetts Association of Math Leagues at the Annual Awards Night presentation in May 2014.
