RE: Report on Professional Learning Day, November 5, 2013

This year, Professional Learning Day was planned and organized by individual schools and/or departments to support the learning and work of their respective goals. Below are the Professional Day summaries from the schools and departments of the Acton Public Schools and the Acton-Boxborough Regional School District.

Conant and Gates Schools: Submitted by Damian Sugrue and Lynne Newman

The Gates and Conant school faculties met together at the Conant School. The focus of the day was to explore informational writing across the curriculum. Materials from Lucy Calkins, the Common Core, and a variety of web-based resources were utilized to provide background information. The small and large group protocols and group discussions that were used allowed teachers to explore the materials and select lessons and topics to use with students in the near future. Plans were discussed to have teachers continue to work together to develop their own writing instruction practice, as well as holistically score writing samples within the grade levels. Overall it was a very well-received and productive day.

Douglas School: Submitted by Chris Whitbeck

Professional Learning Day at Douglas was described by one teacher as a "breath of fresh air." We studied the ideas of Yong Zhao and Ken Robinson and used them as a foundation of our school vision. We analyzed the results of a school vision survey and engaged in deep discussion of trying to identify what we believe and how we want to approach education. After lunch, teachers applied this thinking to crafting curricular experiences that might lead to harnessing student creativity and passion.

McCarthy-Towne School: Submitted by David Krane

The recent Professional Learning Day was a great success. There are always issues for a school to explore thoughtfully and having this be designated a building-based day was very helpful. We spent the morning looking at our End-of-the-Year Summary Reporting document, using a Charrette protocol. The committee members who had developed the document over the course of last year facilitated the conversation in six small groups. One result that emerged was an interest in looking more carefully at what McCarthy-Towne calls portfolio assessment and making some adjustments. The afternoon was spent taking a closer look, as a whole school, at Read Aloud and Purposeful Talk and the implications for instruction across the grade levels. Sharon Ryan presented a slide show, *Purposeful Talk to Enhance Comprehension*, which incorporated the work of Kathy Collins, Ginny Lockwood,

Lucy Calkins, and Maria Nichols, among other scholars and practitioners. As we, as a school, move more deeply into the Reader's Workshop, use of specific language in conversation, both teacher and student, becomes more important in the teaching of critical comprehension strategies. This was the work of the afternoon. Finally, we took some time for colleagues to share their summer learning experiences in the context of the Reader's Workshop and Sharon Ryan's presentation. Although some of the sharing was planned as part of the afternoon, other teachers spontaneously spoke about their work at Teachers College or at the Summer Homegrown Institute. We are truly a learning community!

Merriam School: Submitted by Ed Kaufman

At Merriam School we divided the day into two parts. In the morning we took a look at our school philosophy, and the structures and strategies we use to implement that philosophy. We looked back at a handbook from 1994 – as a way to analyze how we've grown and changed over the years. This work will be brought back to a committee that will study the aspects of our programs that need to be energized and those that require less emphasis. We also will be planning 20th anniversary celebration as a way to mark this important year in the school's history.

After a delicious "Teacher Appreciation Lunch" provided by the PTO parents, we took a close look at our new "End-of-Year Document." Our committee worked several years creating this document, and in this meeting it was shared with the whole staff. We reviewed how to make the completion and delivery of the document as consistent as possible. Ed will write up a summary of our document guidelines to be handed out to the staff, and the document will be presented to parents at an upcoming PTO meeting. It was a productive and enjoyable day!

R.J. Grey Junior High: Submitted by Andrew Shen

This year, our Professional Day was divided into two sessions for most of the certified professional staff. In the morning session, the majority of departments continued to develop and refine the common assessments that they anticipate using next year as District Determined Measures (DDMs). The majority of departments has completed at least one, if not both, of their DDMs and will be prepared to pilot those assessments at some point this year.

In the afternoon, we continued our emphasis on integrating technology into the curriculum – both as an instructional tool and as a skill for students to learn. The technology workshops were facilitated by members of the RJ Grey staff (colleagues teaching colleagues), as well as members of the AB EdTech staff. Some of the workshops provided additional guidance with the AB Schools platform, and others were led by teachers who demonstrated their use of various Web 2.0 applications in their instruction. In addition to these activities, members of the RJ Grey staff who are participating in the District's literacy initiative met to continue a very important interdisciplinary dialogue about literacy and reading strategies within each subject area. Finally, our classroom assistants joined other support staff from around the District to participate in a training offered by Pupil Services on student engagement strategies and de-escalating difficult student situations.

Acton-Boxborough Regional High School: Submitted by JoAnn Campbell

The morning of November 5 was dedicated to mental health education and awareness at the high school. Faculty and staff heard presentations from members of the counseling department, as well as an interview with a former student who shared his experiences as a high school student who struggled with depression. Information in the morning session included the following:

- Current statistics related to hospitalizations and students who are accessing STAR services to transition back to school post-hospitalization.
- Statistics based on the most recent Youth Behavior Risk Survey.
- A presentation on the impact of depression and anxiety on student learning and how students might present in class while struggling with one or both.
- An overview of current supports and structures at the high school, including Student Support Team (SST), STAR, and the roles that counselors and school psychologists play in supporting students.
- Suggested strategies for classroom teachers to use in supporting students, as well as best practices to partner with the counseling department.
- An overview of next steps for the year, including joint planning with the PTSO on parent forums and student-led initiatives.

During the afternoon session, faculty met by departments with consultant Deb Merriam to continue work on District Determined Measures of Student Growth (DDMs). Groups were able to ask clarifying questions about the construction of DDMs, and Deb provided models for alternative measures of student growth beyond the test/quiz form of assessment. This work will continue for the course of the year.

Performing Arts 7-12: Submitted by Mark Hickey

All members of the performing arts department attended their assigned school's morning professional learning sessions. During the afternoon we came together at the high school, where I met with them as three different groups (drama / elementary music / regional music) to provide each with some training and further development of the DDMs that will be used for the teacher evaluation process beginning next year.

Visual Arts 7-12: Submitted by Diana Woodruff

During the morning the high school art staff attended sessions on mental health and during the afternoon worked with a consultant on DDMs. The art staff also worked together to develop DDMs for high school art courses.

Junior high art teachers met with other exploratory teachers at RJG to discuss and brainstorm ideas for DDMs in the morning session. They participated in Technology Workshops for the afternoon session.

Elementary art staff from Douglas, Conant and Gates worked on DDMs for both morning and afternoon sessions. Art faculty at Parker Damon met in their respective buildings for morning sessions (McCarthy-Towne: Protocols and Literacy; Merriam: Old and New

Structures) and then joined other elementary art staff at Gates School to develop a DDM for grade 1 Visual Memory Drawings.

Physical Education and Health: Submitted by David James

The K-6 Physical Education Department met to discuss the Elementary Physical Education Family Nights and District Determined Measures (DDMs) and worked on updating our K-6 learning goals. The discussion of the PE Family Nights centered on how successful and well attended they were this year and planning and preparing for an additional elementary school PE Night next year. We shared the progress of our DDM implementation of jump rope, half-mile run, and overhand throw and how we will determine growth in the spring. Finally, we collaborated on modifying our K-6 learning goal to be more current.

Nursing: Submitted by Diana McNicholas

Both Acton and Acton-Boxborough nurses attended Northeastern University's School Health Institute program: *An Update for School Nurses*. This well-attended school nurse program included the following topics and discussion: critical thinking, lice policy and procedures, adolescent reproductive health, the SANE (Sexual Assault Nurse Examiner) program, latest trends in tuberculosis response, the American with Disabilities 504 implementation, community gang updates, and most currently, a flu update: H7N9. The high school nurses also attended the early morning counseling presentation on Mental Health and Wellness.

Educational Technology: Submitted by Amy Bisiewicz

For Professional Day 2013, the EDTech Operations divided into two groups in which one group went to an Apple Tech Update conference to learn about iOS7, iPad Management, and the new Volume Voucher Program. The second group stayed on campus to support district-wide break out sessions on technology and to begin renovations on the old Cisco lab at the High School. The EDTech Academics team supported the Junior High as their staff embarked on a technology-infused Professional Learning Day. Our staff presented and/or led breakout workshops in Podcasting, iPads in the Classroom, and Google Drive/Sites.

Carol P. Huebner Early Childhood Program: Submitted by Joe Gibowicz

Twenty-eight members of the Acton Public Schools preschool staff participated in three professional learning workshops. In attendance were special educators, classroom assistants, speech and language pathologists, Applied Behavior Analysis (ABA) trainers, the preschool BCBA, and the Early Childhood Coordinator. The first workshop, led by Dorry Brown, Director of Emerson College's Group Language Therapy Program, focused on facilitating language use for preschool-aged students and how music can be an integral part of pretend play for children. Dorry Brown has directed the Language Therapy program for more than 30 years with the assistance of graduate students from Emerson's Communication Sciences and Disorders Department. Dorry was able to share her expertise with the preschool staff in this interactive workshop.

Tammy Kucharski, Occupational Therapist, and Anne Dempsey, Physical Therapist, led the second workshop. They focused their presentation on posture, strength and tone, specifically, how motor skill development affects participation during preschool activities.

Finally, all staff met to discuss the process of regionalization and the direct effect on preschool programming. Discussions focused on the differences of the two programs (philosophies, hours, days, physical space, location, number of students) and how the merger will affect a new, integrated preschool program moving forward. As part of the discussion, the staff was asked to share "pros" and "cons," as well as questions they might have regarding program relocation and other relevant issues. Through constructive discussion and a true commitment to forging new partnerships, ideas and action plans were generated for the future.

Support Staff: Submitted by Liza Huber and Julie Towell

Acton and Acton-Boxborough support staff attended a full-day workshop in behavioral safety presented by Quality Behavior Solutions, Inc. Customized to the district needs, a variety of guidelines and strategies were shared to use when dealing with behaviorally challenging situations, including an understanding of why crisis events happen and how crises can be prevented using a variety of supportive interaction techniques.

Feedback from staff indicated that the emphasis on prevention over intervention was a critical element for de-escalating disruptive and/or dangerous behavior and that the simple, evidence-based de-escalation strategies were effective for all populations of students. Moreover, interventions suggested and practiced could be flexibly adapted to a range of circumstances. Feedback confirmed that presenter David Rourke, M.S., provided respectful, non-coercive interventions that empowered staff to reduce risk in our schools.

Community Education, Extended Day Staff: Submitted by Erin O'Brien Bettez

Over the past year, Extended Day Coordinator Sally Cunningham earned Safety-Care Behavior Safety Trainer status. On Professional Day she led a daylong workshop for our Extended Day teachers, covering several key aspects of the Safety-Care curriculum. Teachers learned about the reasons behind challenging behaviors and how to prevent incidents. They were trained in de-escalation techniques. They reviewed good safety practices and how staff behavior enhances safe environments. It was a very productive day, part of an ongoing effort to provide Extended Day teachers with knowledge and tools needed to run a supportive and safe childcare program.

Dear Ms. Banta and members of the Board, Secretary Malone, Commissioner Chester, Senator Eldridge, Representative Benson and Representative Atkins,

At the November 7, 2013 Joint School Committee Meeting, Dr. Stephen Mills, Superintendent of Schools, and Deborah Bookis, Director of Curriculum and Assessment, suggested that the School Committees of the Acton Public Schools and the Acton-Boxborough Regional School District consider voicing their concern regarding the upcoming vote by the Board of Elementary and Secondary Education on the new Partnership for Assessment of Readiness for College and Careers (PARCC) assessments.

The Administration and the School Committees are particularly troubled that the Board will vote to field test this new assessment before a thorough analysis has been completed, including its comparison to MCAS, its effect on School and District Accountability Ratings, and its impact on the Educator Evaluation Process.

The following motion was unanimously approved by the Acton Public School Committee, the Acton-Boxborough Regional School Committee and the Acton-Boxborough Transitional School Committee on November 7, 2013:

WHEREAS: the School Committees of the Acton Public Schools and the Acton-Boxborough Regional School District question the reliability, validity, and equivalency of the PARCC assessment when compared to MCAS.

Thank you very much for proposing and unanimously adopting the motion at last night's school committee meeting concerning the new Partnership for Assessment of Readiness for College and Careers (PARCC) assessments.

For each of the reasons cited in the motion, we are proud to stand beside you and proudly echo the sentiment so powerfully and eloquently expressed last night.

When school districts as respected as ours make such a public statement, it sends a very powerful message to the Department and Board of Elementary and Secondary Education and to your colleagues around the Commonwealth. I hope that the action you took last night will provide others the motivation and courage to pass similar motions. Perhaps the power of those numbers will have the influence we desire.

As you may know, Deborah Bookis and I met last year with Senator Eldridge and Representative Benson to discuss these very concerns, and they expressed their support for our position. The actions you took last evening will certainly serve to embolden their advocacy and hopefully encourage them to seek a legislative remedy if that proves to be necessary.

Many of the recent actions and decisions from our state's educational leaders have been troubling. It is appalling that the state has decided to release to the public school-by-school educator evaluation ratings.
